

**CERTIFICATE FOR PARTIAL SALES TAX EXEMPTION (cardlock accounts only)**  
**Qualified Sales and Purchases of Diesel Fuel for Farming Activities and Food Processing**  
**and Farm Equipment and Machinery**

NOTE: This is an exemption only from the state general fund portion of the sales and use tax rate. You are not relieved from your obligations for the local and district taxes on this transaction. This partial exemption also does not apply to any tax levied pursuant to Section 6051.2 and 6201.2 of the Revenue and Taxation Code, or pursuant to Section 35 of the article XIII of the California Constitution. This partial exemption also applies to lease payments made on or after September 1, 2001 for tangible personal property even if the lease agreement was entered into prior to September 1, 2001.

**Farm Equipment and Machinery (and the parts thereof)** – I, as the undersigned purchaser, hereby certify that I am engaged in an agricultural business described in Codes 0111 to 0291 of the Standard Industrial Classification (SIC) Manual, or I perform an agricultural service described in Codes 0711 to 0783 of the SIC Manual for such classified persons. The property purchased or leased will be used primarily in producing and harvesting agricultural products in accordance with Revenue & Taxation Code 6356.5. NOTE: If you are purchasing oil, grease or other qualifying fluids, indicate what percentage will be used in farm equipment and machinery performing qualified producing and harvesting activities: 100 %. Vehicles that qualify as farm equipment and machinery as defined in Regulation 1533.1(b)(1)(B) must be used exclusively in producing and harvesting agricultural products. **(Food processors and agricultural produce haulers do NOT qualify for this exemption.)**

I understand that if such property is not used in the manner qualifying for the partial exemption, or if I am not a qualified person, that I am required by the Sales and Use Tax law to report and pay the state tax measured by the sales price payable of the property to/by me. I also understand that this partial exemption certificate is in effect as of the date shown below and will remain in effect until revoked in writing.
